

Travel Reminders

Travelers should seek to identify and weigh the risks associated with international travel based on their personal circumstances.

- If you plan to leave and re-enter the U.S., be sure you have all the re-entry documents: valid passport, visa stamp, Form I-20, DS-2019, or I-797.
- If you need a new travel signature, use the travel signature request in iTerp. If you request a new travel signature, remember to download, print and sign before you re-enter the U.S.
- If you are taking a cruise, the cruise officials may want to see your printed and signed I-20/DS-2019 BEFORE you board. Make sure you have the documents needed to re-enter the U.S. after your cruise
- Currently, a Presidential Proclamation Orders Travel Bans on 19 Countries. Presidential Proclamation of June 4, 2025: [Restricting The Entry of Foreign Nationals to Protect the United States from Foreign Terrorists and Other National Security and Public Safety Threats](#) establishes a "full" travel ban on 12 countries and a "partial" travel ban on 7 countries, effective as of June 9, 2025. - On June 18, 2025, the [Department of State announced new guidance](#) on social media vetting and the resumption of visa processing for F and J visas

Domestic Travel

In the Maryland, D.C., Virginia area: You should always have your I-94 record available (on your phone or carry a print out). By law, foreign nationals 18 years and older are required to carry proof of their immigration status ("registration") with them.

Some distance from the Maryland, D.C., Virginia area: You should bring the following original documents on your trip: Passport, I-20, DS-2019, or I-797 (printed and signed), printout of your most recent electronic [Form I-94](#).
